(Company No. 863787-X), a company incorporated under the laws of Malaysia and having its place registered address at No. 9, Jalan Indah 16, Taman Cheras Indah, 56100 Kuala Lumpur, Malaysia and its place of business at Block B, 1 – 32A Jalan Pandan Prima 2, Dataran Pandan Prima, 55100 Kuala Lumpur, Malaysia (hereinafter referred to as the said “Company”) of the first part

AND

COMPANY NAME (Company Reg. No. _____), a company incorporated under the laws of Malaysia and having its place registered address at _____ and its place of business at _____ (hereinafter referred to as the said “Merchant”) of the other part.

WHEREAS

1. The Company is in the business of conducting network marketing and e-commerce by providing the portal for on-line commercial transactions as well as in the business of developing software and the Company is the developer and owner of the copyright in respect of various software packages.
2. The Merchant is desirous of using these software packages developed by the Company and the Company is agreeable to granting the Merchant a license subject to the terms and conditions set forth herein.
3. This Agreement explains the terms and conditions governing your use of the Ads4Merchant On-Line (Ads4Mall) or Off-Line solution, technology and any other content available during your sign-up period. By signing at the end of this document, you have chosen to accept these terms and conditions and acknowledge that the Ads4Merchant On-Line (Ads4Mall) or Offline solution during this sign-up period is governed by the rules set forth below. If you do not wish to accept this agreement, do not proceed with the sign-up.
4. By accepting this Agreement, You further agree to be bound by any amendments to the terms and conditions of this Agreement or to such terms and conditions as are incorporated herein by reference.

NOW IT IS HEREBY AGREED by the parties to this Agreement as follows :

PRIVACY POLICY

This Privacy Policy applies to the web site of Ads4Mall (the "Site") an online commercial portal provided for the use of agents or Ads4Bucks Merchants to perform commercial transactions worldwide with also it's own payment gateway called Ads4Pay. This site is under the main website www.ads4bucks.com, a 100% on-line free advertising, social networking, Affiliate Program and a Business Portal designed and provided by Ads4Bucks Network Sdn. Bhd. (Company No.: 863787-X) (hereinafter referred to as "Ads4Bucks") located at its registered office and its main place of business at Block B, No. 1-32A, Jalan Pandan Prima 2, Dataran Pandan Prima 55100 Kuala Lumpur.

As an internet based company which providing web services to the public worldwide, Ads4Bucks is committed to safeguarding your privacy online. Please read the following to fully understand our practices regarding the use of your personal information. By using the Site, you consent to the data practices described herein.

This policy applies specifically to name, e-mail address, telephone number, and any other individually identifiable information which we may collect from you.

WHAT WE COLLECT

Our general policy is to only collect individually identifiable information that is absolutely necessary for the processing transaction or useful for our own internal purpose operations. During the registration process and creation of an account, for accountability purposes, we do require a user to provide their Malaysian Identification Card (NRIC) number, e-mail address and mobile number. For the purposes of this Privacy Policy, "Personal Data" shall include, where applicable, to your name, your identity document details, your company name (if relevant), your business's name, your contact details, your user identification and password to the Site, and all other information which may identify you or group or a business entity.

We do keep record of the e-mail addresses and messages of those who publish, post messages, photographs, communications and comments or feedback on the Site, or who communicate with us via e-mail.

We also keep record of the information on what pages our users access or visit, information volunteered by users and merchants, such as Site registration data and/or survey information, and the contact details, e-mail address of buyers, sellers and merchants on the Site.

We also track certain particulars about you which includes the URL that you just came from or you next go to (whether this URL is on the Site or not), browser type, access times, the pages you visit and your IP address. Many sites automatically collect this information using widely available site web statistical tools.

COOKIES

A cookie is a small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site's computers and stored on your computer's hard drive. In our case, cookies are used to record current session information.

Cookies are also used so that the User does not have to enter his or her login information each time they visit the Site. An added security feature for any user would be to clear your browsing history, cookie or cache from time to time or if preferred after every session.

WHAT WE DO WITH INFORMATION COLLECTED

The security of your personal information is important to us. We collect and use your information for the registration process, to operate the Site and to deliver to you the Services you have requested, including but not limited to (a) fulfilling your requests for, or to inform you of, products and services (where applicable); (b) contacting you; (c) conducting research; (d) providing anonymous reporting for internal and external clients; (e) resolving disputes and troubleshoot problems; and (f) enforcing our terms and conditions for using the Site.

We will disclose your information, without notice, when required to do so by law or in the good faith belief that such action is necessary to (a) conform to the edicts of the law or comply with legal process served on us or this Site; (b) enforce the terms and conditions of use of this Site; (c) protect and defend our rights or property and this Site; (d) act under exigent circumstances to protect the interests of our users, this Site or others; and (e) investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the personal safety of any person or as otherwise required by law.

We reserve the right to transfer information provided by you in the event we are acquired by or merged with another company.

CREATING A PUBLIC PROFILE

Under the "Contact" feature, we give you an option to provide your contact numbers under the

“Profile” page, containing personal information that you have volunteered so that other members/users and other public areas can make contact with you. Although entering profile information is not compulsory, adding more details will make it easier for prospects or clients or interested parties to get in touch with you. When you make a posting, the information will be made available to everyone, which may include users who are not registered.

While participating in the Site or other public areas, we strongly advise you against giving out personally identifiable information to strangers online, which they may use for illegal or harmful purposes.

YOUR ABILITY TO EDIT YOUR ACCOUNT INFORMATION

You can update or edit your personal information at any time by clicking on the “Profile” link.

We reserve the right to send you marketing communications and communications relating to the Services, such as service announcements, administrative messages and newsletters, from time to time. In the event that you receive an e-mail or mobile message that you think is unsolicited, please inform us via e-mail to admin@ads4bucks.com.

SECURITY MEASURES

The security of your personal information is important to us. We employ commercially reasonable security methods to prevent unauthorized access, maintain data accuracy and ensure correct use of information.

As a Registered User, your Registration Information and other transaction details can be viewed and edited through your Account which is protected by Password. We recommend that you do not divulge your Password to anyone. Our personnel will never ask you for your Password in an unsolicited phone call or in an unsolicited e-mail. If you share a computer with others, you should not choose to save your log-in information (e.g., User ID and Password) on the computer. Remember to sign out of your Account and close your browser window when you have finished your session. An added security feature would be also for you to clear your browsing history, cookie or cache from time to time or if preferred after every session.

No data transmission over the Internet or any wireless network can be guaranteed to be perfectly secured. As a result, while we try to protect your information, no web site or company, including ourselves, can absolutely ensure or guarantees the security of any information you transmit to us and you do so at your own risk.

This Agreement helps to keep www.ads4bucks.com/Ads4Mall a safe place to buy and sell items. We would like to build www.ads4bucks.com/Ads4Mall on trust, and this Agreement helps ensure that trust amongst all members of our community.

We may amend this agreement at any time by posting the amended terms on our site. The

amended terms shall automatically become effective after they are posted on our site. Your continued use of this site constitutes the following :

1. Acknowledgment of this Agreement and any modifications; and
2. Agreement to abide and be bound by this agreement, including any modifications.

ELIGIBILITY FOR MEMBERSHIP

Our services are available only to registered merchants, and may only be used by individuals who can form legally binding contracts under applicable law. You may not act as an agent for another person nor open an Ads4Mall account for another person (no beneficial ownership is permitted). You may open a business account, but Ads4Mall may require additional information regarding you or the business to verify your ability to act on behalf of such business. Without limiting the foregoing, our services are not available to children (persons under the age of 18) or to temporarily or indefinitely suspended Ads4Mall members or to persons who present an unacceptable level of risk. The Ads4Mall account and User ID is not transferable and cannot be sold to another party. NO AGENCY.

You and Ads4Bucks/Ads4Mall are independent contractors, and no agency, partnership, joint venture, employee-employer or franchiser-franchisee relationship is intended or created by this Agreement.

FEES AND SERVICES

Being an Ads4Bucks agent only requires a one time payment of RM420 (Malaysia Only) for a Platinum Buck Package where you will receive the Virtual Office, SMS Blaster (Bulk SMS), Personal Blog (ads4blog.net – 100MB), E-Library, E-Audio, Ads4Mall, Ads4Mall personal email id (eg. david@ads4mall.com – Coming Soon) and BIO Energy Card (FREE). We may choose to temporarily change our Fees for promotional periods (for example, festive seasons or new packages / services / upgrade) and such changes are effective when we post the temporary promotional event on the Site.

We may in our sole discretion change some or all of our services at any time. In the event we introduce a new service, the fees for that service are effective at the launch of the service. Unless otherwise stated, all fees are quoted in RM (Ringgit Malaysia). You are responsible for paying all fees associated with using our service and the Site and all applicable taxes.

Ads4Bucks may from time to time review and change how members can access the site. Such changes will be posted on the site and shall become binding upon its implementation.

In addition when one becomes an Ads4Merchant there is a small processing fee that is

mentioned in the Ads4Merchant Registration Form.

ADS4MALL IS ONLY A LOCATION

Ads4Mall is an online E-commerce solution platform web site, it is important to realize that we are not a traditional "seller." Instead, the Site acts as a location to allow anyone to offer, sell, and buy just about anything (the items registered to be sold on the Site has to comply with some of Ads4Bucks list of preference) , at anytime, from anywhere, in a fixed price format specified by the seller using this commonly referred to as "online mall". We do not get involved in the actual transaction between buyers and sellers.

Information and images posted by a member may be offensive, harmful or inaccurate, and in some cases will be mislabeled or deceptively labeled. TRANSACTIONS

i-bucks is the currency created by Ads4Bucks for the sole purpose of Ads4Pay which has been created for transactions with Ads4Merchant on-line and off-line. Cash is also accepted but it is solely at the discretion of the Merchant.

Minimum purchase/top up of *i*-bucks is RM5 (except for credit card). *i*-bucks purchased from Ads4Bucks is not transferable. Ads4Bucks may buy back the *i*-bucks from the customer at a rate determined and Ads4Bucks may amend/change/revised the rate at any time by posting a revised version on Ads4Bucks site.

All transactions on purchase of *i*-bucks are limited to requirements and operations of FPX (Financial Process Exchange). Transaction can only be made within 7a.m to 11p.m daily (including week end and public holiday). Ads4Bucks will forward the *i*-bucks once full payment has been received from customer. Ads4Bucks only allows payment made in full amount. Purchases with multiple payments -like deposit followed by a final payment will not be entertained.

DELIVERY OF GOODS

Ads4Bucks will not be liable for any products purchase on the Ads4Mall. Ads4Bucks is not liable for any late delivery or extra/additional charges applied to customer by the merchant. If there is any failure of delivery of merchandise or defects on merchandise delivered, Ads4Bucks is not liable and the customer will have to settle it directly with the merchant. We do not have any control over, and are not responsible or liable for, the products or services that are paid for with our service. We cannot ensure that a buyer or a seller you are dealing with will actually complete the transaction.

We do not transfer legal ownership of items from the seller to the buyer, and nothing in this agreement shall modify the governing provisions of section 19 of the Sale of Goods Act 1957, under which legal ownership of an item is transferred when the parties (i.e., seller and buyer) intend to transfer such legal ownership. Furthermore, we cannot guarantee continuous or secure access to our services, and operation of the sites may be interfered with by numerous factors outside of our control. RETURN AND CANCELLATION

Return of customer purchase consideration is subjected to the terms and conditions set up by the merchant. Customer is liable to return any false transaction. If any transactions are incomplete or unsatisfactory, Customer should attempt to resolve the dispute directly with the seller. Ads4Bucks does not has control over and are not responsible or liable if any of these cases occurred.

FRAUD, CHEATING OR SCAM

Ads4Bucks is not liable to any fraudulent, identity theft, cyber crime or online threats. By using this website for transactions, you agree that Ads4Mall is only a venue and is not responsible for any losses which may arise from Fraud, Cheating or Scam from your buying, selling or direct negotiation or transaction conducted within buyers or sellers.

We are not responsible for any losses which may arise from Fraud, Cheating or Scam which may be due to you clicking on any of the banners you may find or which may appear on the Ads4Mall which may re-direct you to any third party website. Ads4Bucks is not liable to any transaction conducted due to this re-direction.

IDENTITY VERIFICATION

We use many techniques to verify the accuracy of the information our users provide us when they register on the Site. However, because user verification on the Internet is difficult, Ads4Mall cannot and does not confirm each user's claimed identity. For a valid member, we solely rely on National Registration Identification Card (NRIC) submitted via FAX or E-mail. Thus, we have established a user-initiated feedback system to help you evaluate with whom you are dealing with. We also encourage you to communicate directly with potential trading partners / merchants through the tools available on the Site.

RELEASE

Since Ads4Mall is a venue, in the event that you have a dispute with one or more users, you release Ads4Bucks, Ads4Mall and Ads4Pay (and our officers, directors, agents, subsidiaries, joint ventures and employees) from any and all claims, demands and damages (actual and consequential) of every kind and nature, known and unknown, suspected and unsuspected, disclosed and undisclosed, arising out of or in any way connected with such disputes.

CHECKOUT AND BUYING

By checkout on an item you agree to be bound by the conditions of sale included in the item's description so long as those conditions of sale are not in violation of this Agreement or unlawful. Unless you and the seller agree otherwise, or unless the item is listed in a category that is prohibited by law or by this Agreement. You will become the item's lawful owner upon physical receipt of the item from the seller. Checkouts are not retractable except in exceptional circumstances, such as: when the seller materially changes the item's description after you checkout; a clear typographical error is made.

LISTING AND SELLING

You must be legally able to sell the item(s) you list for sale on the Site. You must describe your item and all terms of sale on the listing page of the Site. Your listings may only include text descriptions, graphics, pictures and other content relevant to the sale of that item. All listed items must be listed in an appropriate category. All items sold in quantity must be identical (the size, color, make, and model must be the same for each item unless specified). We reserve the right to remove a members listing if found that :

1. Seller's registration details and contact information is in-valid, not contactable, or misleading.
2. Seller has been suspended from trading for any other reason which against our guideline, rules and regulations.

You may not list on our site or sell any item using our site which:

1. Infringes any third party's copyright, intellectual property, patent, trademark, trade secret or other proprietary rights or rights of publicity or privacy;
2. Otherwise causes legally-recognized harm (such as a product that contains a defamatory statement); or

4. Or anything disclosed in our prohibited and restricted items.

YOUR INFORMATION

Definition. "Your Information" is defined as any information you provide to us or other users in the registration, purchasing or listing process, in any public message area (including the community forum, photo or the feedback area) or through any email feature. You are solely responsible for Your Information, and we act as a passive conduit for your online distribution and publication of Your Information.

RESTRICTED ACTIVITIES

Your Information (or any items listed) and your activities on the Site shall not:

- (b) be fraudulent or involve the sale of counterfeit or stolen items;
- (c) infringe any third party's copyright, patent, trademark, trade secret or other proprietary rights or rights of publicity or privacy;

LICENSE

Solely to enable Ads4Bucks/Ads4Mall to use the information you supply us with, so that we are not violating any rights you might have in that information, you agree to grant us a non-exclusive, worldwide, perpetual, irrevocable, royalty-free, sublicensable (through multiple tiers) right to exercise the copyright, publicity, and database rights (but no other rights) you have in Your Information, in any media now known or not currently known, with respect to Your Information. Ads4Bucks/Ads4Mall will only use Your Information in accordance with our Privacy Policy.

ACCESS AND INTERFERENCE

The Site contains robot exclusion headers. Much of the information on the Site is updated on a real time basis and is proprietary or is licensed to Ads4Bucks/Ads4Mall by our users or third parties. You agree that you will not use any robot, spider, scraper or other automated means to access the Site for any purpose without our express written permission. Additionally, you agree that you will not: (i) take any action that imposes, or may impose in our sole discretion an unreasonable or disproportionately large load on our infrastructure; (ii) copy, reproduce, modify, create derivative works from, distribute or publicly display any content (except for Your Information) from the Site without the prior expressed written permission of Ads4Bucks/Ads4Mall and the appropriate third party, as applicable; (iii) interfere or attempt to interfere with the proper working of the Site or any activities conducted on the Site; or (iv) bypass our robot exclusion headers or other measures we may use to prevent or restrict access to the Site.

CURRENCY, TAXES AND OTHER CHARGES.

Your account and all transactions are made and displayed in *i-bucks* unless otherwise specified and may be subject to exchange rates. All fees related to the Service, are made free and clear of, and without any deduction or withholding for and on account of, any taxes, duties or other deductions. Any such deduction or withholding, if required by the laws of any country, shall be on your account and be borne by you. Any currency conversion changes will be borne by the customer.

HOLD, SUSPEND AND RESTRICT.

In order to ensure the integrity of a transaction Ads4Bucks/Ads4Mall reserves the right to hold funds or proceeds from transactions by placing them in a pending or hold status beyond the

normal distribution period. Ads4Bucks/Ads4Mall may do this in order to mitigate risk related to transactions it considers suspicious.

If you engage in any violation of any law or wrong behavior, Ads4Bucks/Ads4Mall may suspend or restrict your access to the services, hold your funds up to 90 days, fine you or report you to law enforcement officials.

Ads4Pay, in its sole discretion, may place a reserve on funds held in your Account when Ads4Pay believes there may be an increased level or risk associated with your account. If Ads4Pay places a reserve on funds in your Account, they will be shown as pending in your Ads4Pay Account. If your Account is subject to a Reserve, Ads4Pay will provide you with notice specifying the terms of the reserve. The terms may require that a certain percentage of the amounts received in your Account are held for a certain period of time, or that a certain amount or percentage is held in reserve. Ads4Pay may change the terms of the reserve by providing you with notice of the new terms. In the event you do not agree to the terms of the reserve, you may stop using Ads4Pay.

Without limiting other remedies, we may at any time and without notice to you update inaccurate or incorrect information you provide to us, contact you by means other than electronically, immediately to warn our community of your actions, place a hold on funds in your account, limit funding sources and payments, limit access to an account and any or all of the account's functions (including but not limited to the ability to send money or making withdrawals from an the account), limit withdrawals, indefinitely suspend or close your account and refuse to provide our Services to you if: (a) you breach this Agreement or the documents it incorporates by reference; (b) we are unable to verify or authenticate any information you provide to us; (c) we believe that your account or activities pose a significant credit or fraud risk to us; (d) we believe that your actions may cause financial loss or legal liability for you, our users or us; or (e) your use of your Ads4Pay account is deemed by Ads4Pay, Visa, MasterCard, American Express or Discover to constitute abuse of the credit card system or a violation of credit card rules, including (without limitation), using the Ads4Pay system to test credit card behaviors. Even if transactions have been recorded as completed in the recipient Ads4Pay Transactions or Personal Shopping Report, Ads4Pay reserves the right to reverse transactions if the funds can not be or have not been charged to the customer's funding source or confirmed from the sender's bank account).

In addition, Ads4Pay reserves the right to hold funds beyond the normal distribution periods for transactions it deems suspicious or for accounts conducting high transaction volumes to ensure integrity of the funds. If we close your account, we will provide you notice and pay you all of the unrestricted funds held in your Ads4Pay account. Additionally, to secure your performance of this Agreement, you grant to Ads4Pay a lien on and security interest in your account. In addition, you acknowledge that Ads4Pay may set off against any Ads4Pay accounts you own for any negative balance in your other Ads4Pay accounts, at any time and for any reason allowed by law. Further, Ads4Pay may set off against any Ads4Pay accounts you own for any obligation you owe Ads4Bucks/Ads4Mall or any of its subsidiaries that is 180 days or greater past due. These obligations include both secured and unsecured debts, and debts you owe individually or

together with someone else.

Unless otherwise stated, all fees are quoted in Malaysian Ringgit. You are responsible for paying all fees and applicable taxes associated with our sites and services in a timely manner with a valid payment method. If your payment method fails or your account is past due, we may collect fees owed using other collection mechanisms. (This includes charging other payment methods on file with us, retaining collection agencies and legal counsel, and for accounts over 180 days past due, deducting the amount owed from your Ads4Pay account balance.)

While using Ads4Bucks/Ads4Mall, services and tools, you will not:

- post content or items in an inappropriate category or areas on our sites or services;
- violate any laws, third party rights, or our policies such as the prohibited and restricted Items policies;
