ADS4MERCHANTS TERMS & CONDITIONS

1. Applicant must have a legally registered and running a business.
2. Applicant must use the official Merchant Application Form purchased from the Ads4Bucks HQ.
3. Applicant must provide their actual and complete details to Ads4bucks.
4. Applicant must pay the required application fees.
5. Ads4bucks reserves the rights to approve or reject any application without prejudice.
6. If their application is rejected, the company will refund their fees in full.
7. Merchant must be willing to accept *i-bucks* (Ads4Pay) as payment.
8. Merchant must treat Ads4bucks agents as normal customers when selling their products or providing services to them.
9. Merchant must be willing to co-operate with Ads4bucks on marketing strategies, advertising & promotion activities.
10. Our business operation is from 12.01a.m till 12.00a.m.. Ads4Bucks will only forward the cash consideration paid by the customer to the merchant within 24 hours. Payment for transaction took place on Friday, Saturday and Public holiday will be made on the next working day.
11. All payments to merchants are limited to requirements and operations hours of banks in Malaysia. Transaction can only be made within 7.00a.m. to 11p.m. daily (exclude weekends and public holiday).
12. Ads4bucks will provide a door sticker for merchants to display in front of their shops so it is easier for Ads4bucks agents to recognize the merchants.
13. Sellers on Ads4Mall are required to specify a return policy in their item listings. This is true even if the seller's policy is not to accept returns.
14. Only online merchant is required to sign up as our Platinum member.
15. Should there be any return of goods, rebates awarded will remain with Ads4Bucks.
16. In the event that you have a dispute with one or more users, you release Ads4bucks, Ads4Merchants, Ads4Mall and Ads4Pay (and our officers, directors, agents, subsidiaries, joint ventures and employees) from any and all claims, demands and damages (actual and consequential) of every kind and nature, known and unknown, suspected and unsuspected, disclosed and undisclosed, arising out of or in any way connected with such disputes.
17. All fees related to the Service, are made free and clear of, and without any deduction or withholding for and on account of, any taxes, duties or other deductions. Any such deduction or withholding, if required by the laws of any country, shall be on your account and be borne by you. Any currency conversion changes will be borne by the customer.
18. If a Merchant is found to have engaged in some/any violation of any law or wrongful behavior, Ads4Merchant may suspend or restrict your access to the services. Ads4Bucks has all the rights to hold the funds up to 90 Days, fine you, as explained below, or report you to law enforcement officials.
